## **ABOUT JAI BHIM**

Jai Bhim Vikas Shikshan Sansthan was established in 1993, mainly working on two Core Themes: Fundamental Rights and Livelihood of the marginalized communities, in the western and eastern parts of Rajasthan. The organization has addressed hundreds of cases of land encroachment and atrocities by mobilizing the oppressed and advocating with the law enforcement agencies. The organization has been steering the Dalit rights campaign for last eight years in the area and has formed more than 160 community-based groups of male and female activists. The organization is closely working at grass root level against issues of atrocities, discrimination, and violence and also through advocacy. In its broader sense its efforts are towards ending Untouchability, caste-based discrimination and exclusion.

## **VISION**

Formation of the society based on Justice and Equality.

## **MISSION**

To aware and organize vulnerable and marginalized section of the society, especially Dalit, women and children so that they might improve their living standard by asserting their control over all the aspects affecting their lives.

## **OBJECTIVES OF ORGANIZATION**

- To aware and organize the deprived and marginalized community on the daily life issues like caste, gender and class-based atrocities and discrimination and development of their understanding on the natural rights (education, health and livelihood) for development of leadership in these communities.
- Motivating the women to empower their status, rights and interventions in the society.

- To spread awareness and do advocacy on the issues of gender and violence against women and Dalits.
- Development of awareness and understanding the society for child rights and advocacy for the same.
- Extend interventions towards village development and cleanliness.
- Mobilize the people to get benefits from the government policies/schemes.
- Provide relief and rehabilitation at the time of natural calamities.
- Capacity building of Dalits, women and backward Panchayat Raj representatives.
- Organization provides vocational training for women and youth empowerment in a way to develop both socially and economically.

## Project Childline 1098



Child line 1098, run under Jai Bhim Vikas Shikshan Sansthan is a project initiated by the Ministry of Women and Child Development, Government of India. Child line is a 24-hour free and emergency national phone service. Child line 1098 Jodhpur helps sick, lonely, helpless children or children suffering from some kind of violence, abandoned by families and missing children. It also works to prevent child labor and child marriage.

**Vision-** To establish a nation that guarantees protection of the rights and safety of all children.

**Mission-** The aim of child line is to reach every child who is in need and to ensure their safety and protection of their rights.

## BRIEF

The Child Line (1098) program has a coordinator, a counselor, six team members, and a volunteer who help in protection of rights of children and ensuring their safety throughout Jodhpur. The Child Line Jodhpur team works in unison in which the cooperation of all the team members is very important.

Child Line team fulfills its duties by formulating and executing weekly plans. Child Line Jodhpur spreads awareness about Child Line 1098 Helpline by visiting railway stations, bus stands, police stations, hospitals, city squares, mud slums, slum markets, crowded markets, tourist places, auto stands, schools, colleges, villages, government departments, garbage dumping places in the city and public parks. The members distribute pamphlets to educate people about Child Line Service.

The members also request people to make a trial call on 1098 so that people can know what services are provided in 1098. This also builds a trust in the general public. It also has an advantage that anytime someone sees a needy child, they can easily call 1098.

Through the Child Line, children can be given a bright and safe future in the society. Child Line attempts to ensure that children get a safe and healthy environment and are always smiling. Since May 2013, Jodhpur Child Line has been continuously raising a strong voice against crime and exploitation against children.

From time-to-time, Child Line Jodhpur holds meetings with police stations, government departments, ward councilors, sarpanches, etc. to select the issues faced by children and the Child Line Team coordinates with these entities to

raise voice against such issues and resolve them. A strategy is formulated every month and the team works accordingly to resolve the issues. The work is done to put an end to atrocities faced by children and to assure public that Child Line is indeed always ready 24 x 7 to help children in need.

All the obstacles that come in the work of the Child Line are presented to the Child Advisory Board appointed and headed by District Collector. Child Line is the secretary of the board. The Child Advisory Board consists of all the departments of the district such as Medical department, Health, Education, Police, Child Welfare Committee, Juvenile Justice Board etc.

Child Line ran a campaign under the *Children Welfare Committee* and police authorities to assist in the operation of rescuing children begging at the crossroads in Jodhpur city. 115 children were rescued during this campaign. These children were brought to the Child Line office where they were counselled. Their parents were traced and summoned to office. They were asked to fill form no. 9 under J.J. Act and bounded by law, not to force their children into beggary in future and introduce them to education. Child Line links these children to various government schemes more and more such children to schools.

Child Line in the past 9 years, have has helped children directly, out of which 89 were missing children. These children were mostly child laborers, victims of child marriage, missing, illiterate and child beggars. Today, Jodhpur city admire Child Line and even administration has expressed gratitude for the work done by the Child Line.

With the help of police administration, Child line Jodhpur was able to stop 55 child marriages. A few children were also provided medical facilities. Open House Programs were conducted in some schools in the city which saw participation of around 2800 children.

Because of the efforts of Child Line, today we don't see children begging and collecting garbage in Jodhpur. Child Line, with the help of Children welfare society, has provided orphan and abandoned children with shelter home and education. These children have no arrangement for daily meals. Such children are being helped by the Child Line.

## Project Goals

- B. Facilitate in creation of child friendly police station and build the capacity of stakeholders dealing with child protection. Provide support to the children who are facing neglect and abuse, child marriages and young offenders.
- C. Approach- Identify new cases of POCSO and intervene the existing cases of POCSO by providing them high quality legal aid and rehabilitation services.
- D. Identify and rescue the children from child labour and child trafficking. Rehabilitate the rescued children along with their families.

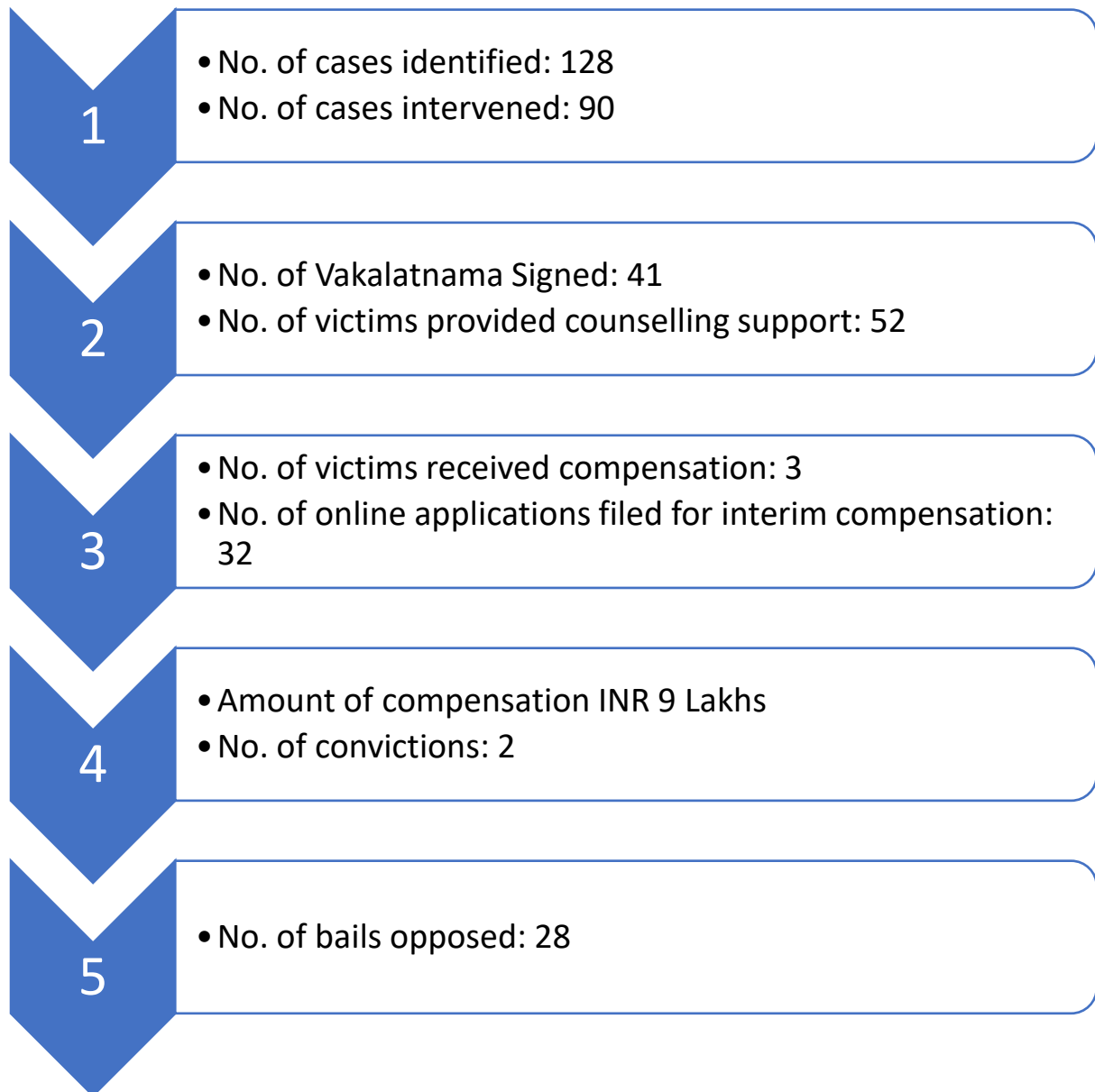


## Creating Child friendly Police Station

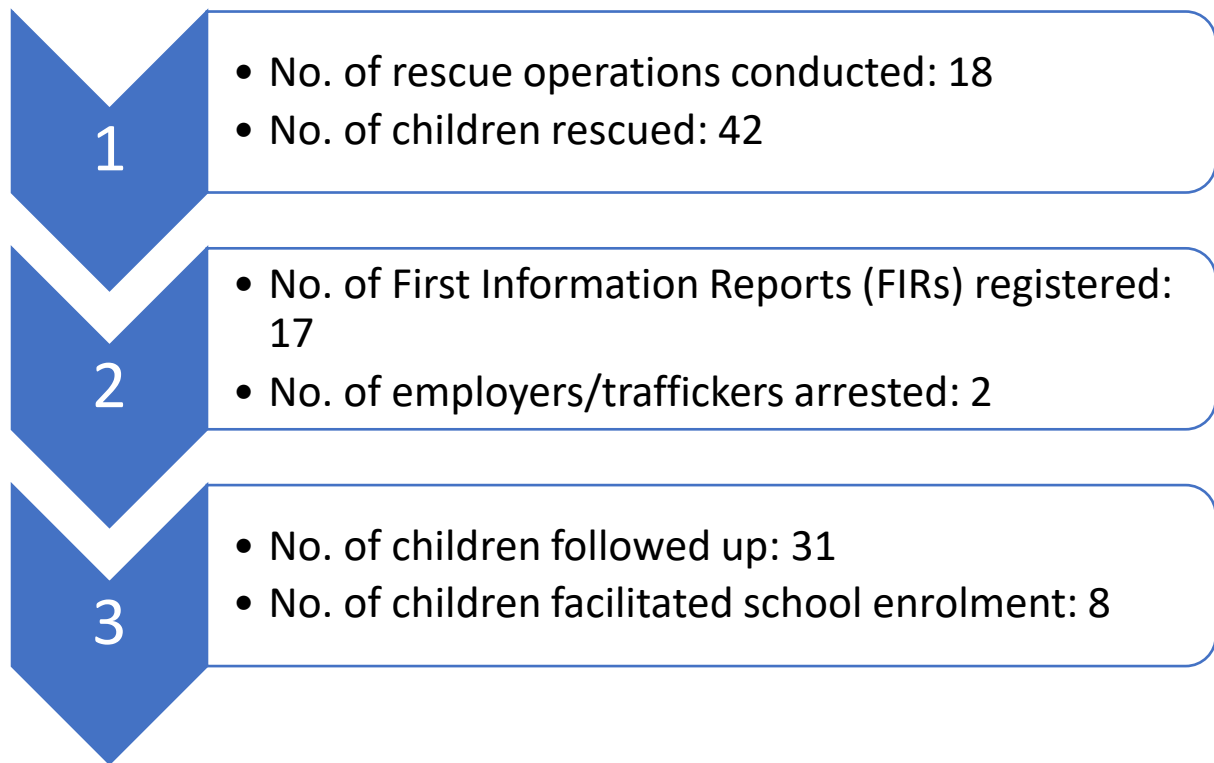

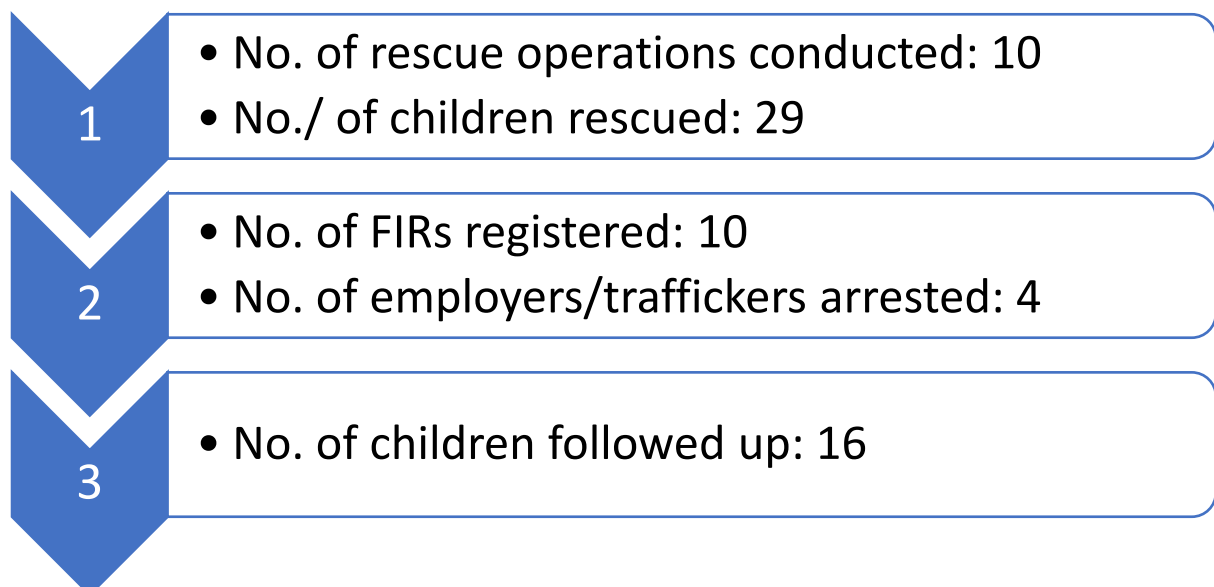

**Case story 1-** A 10-year-old girl was sexually assaulted 5 times in school. the first incident took place in 2020 during annual day practice, where the newly appointed dance teacher took the victim in a corner in the hall where the practice was going on and unpleasantly touched her every private part of her body. two times the girl was sexually assaulted by that dance teacher. once during the practice in 2020 and second time in 2022 after corona times when schools were reopened. one student saw this incident and took advantage of it and he also sexually assaulted the girl two to three times. the teacher and school boy both have threatened to strangle her. the first accused was arrested but the second accuse the school boy was not identified. JBVSS team went to school to identify and report against that boy who raped her. but the school administration denied to support even police identified the child but denied to reveal his identity. but JBVSS approached DLSA who supported in identifying the boy. both the accused were identified and one accused is under custody but another accused is still remaining to present in front of juvenile justice board. the family and the organization tried hard to change the school of the girl and for this district collector, education dept. and DLSA all have been approached but they denied changing her school to some other private school as the admission is under right to education (RTE).





**Case story 2-** A 6-year-old boy was raped by the man in his own society. one day the child was playing with her elder sister when his mother sent him to shop to buy something, the shopkeeper asked that child to come on the terrace of shopkeeper's home as the person and family known to the boy, he went there and the shopkeeper raped that boy. the boy with the blood stains ran to his home there his mother asked him what had happened then he told that the shopkeeper had done something with him. she went to hospital and since it was a case of sexual assault the accused was immediately arrested. the mother is living alone with children in jodhpur so the accused (shopkeeper) mother along with their advocate emotionally blackmailed the victim's mother that the accused is suffering from some severe disease and if medication is not given the accused will die so requested to sign a document so that the accused can get the medicines. the mother was illiterate so without reading she put her thumb impression the documents. later on, when she was called in court, she got to know that the accused family again cheated her and they have taken her thumb impression on compromise documents. the JBVSS counselor and advocate filed another fir of cheating and managed to reject the compromise filled by the accused

## **Project Activities**

The Muktidhara Program has four pillars, these are the related to different processes required to achieve the mission of ending system of bonded labour. These are-

- ❖ **Identification and Rescue process:** - The program is designed to actively identify bonded labour or support help-seekers. Information on local district industries is collected first. Along with-it field surveys are conducted. When leads are identified, the team carefully document the case and bring it in cognizance of district administration. During the rescue JBVSS provides legal and rehabilitation counselling to survivors and administration and also ensure guidelines set in Centre Sector Scheme are complied. After the rescue, survivors are provided release certificates which is valid proof of successful bonded labour rescue.
- ❖ **Aftercare:** - After rescue, JBVSS ensures short term and long-term rehabilitation goals are met for comprehensive welfare of survivors. Rehabilitation program ensures survivors are not re-victimized and their lives are restored or improved to pre-victimization period. Immediately after rescue rehabilitation activities begins which



includes safely repatriating survivors with their families, ration kits and police protection application. Long term rehabilitation activities are planned according to the family development plan which includes need analysis of the survivor family. Here, not only survivor but the rehabilitation activities are designed for every member of the survivor family. Eight domains are especially prioritized that are- health, housing, protection, economic empowerment, education, family relationships, community involvement and trauma recovery etc. Additionally, the rehabilitation team conduct regular follow ups like family monthly meetings, SHG meetings and village welfare meetings.

Survivors after years of abuse have broken self-confidence and lack basic life skills. Rehabilitation team within two months of rescue conducts freedom training in which survivors are informed about their legal rights, various legal provisions and life skills necessary. Periodically, the team also conducts training workshops to improve survivors' leadership skills. These skills help the survivor and their community members to engage more effectively with the local administration. It enables them to voice their needs and bargain fairer welfare policy from state in respect to the injustice they suffered.

**RBLA-** Released Bonded Labour Associations are focused groups having survivors of bonded labour and their community as members. Aim of creating these smaller associations is to provide survivors platform to discuss their political, social and economic status in society and plan activities to raise their position in society through advocacy, creating small cottage commercial units and participating in democratic processes. These associations become foundation for sustainability of aftercare work and is a paramount operational activity for JBVSS whose roots are sown right after rescue. Family development and long-term welfare are then transferred to these associations.

- ❖ **Legal case work:** - After the rescue a complain/FIR is filed against the accused which is regularly followed up by the legal consultants of JBVSS. Legal consultant support public prosecutors and survivors by bridging the gap between the two. Legal case work also includes filing letters to NHRC and state legal association for requesting their intervention in the cases whenever necessary.
- ❖ **System reform:** - System reform activities are done with the aim of enabling policy makers and implementors to create strategies with regard to abolition of bonded labour system in the state. This wing helps to develop sustainability of program

through transferring ownership to state. System reform conduct activities with state level officials such as state consultancy meeting, trainings, liaison, inter department convergence meetings, provide rescue support to case work team through coordinating with state departments, and civil society networking workshops. The paramount operational activity of System reform is to conduct state level training of Labour department, vigilance committees, police training Academy and department, Judicial school, legislative officials, State legal aid service authority, Child welfare committee, Rajasthan commission for protection child rights, Rajasthan skill and livelihoods development corporation and social welfare department.

# System reform



## I. Liaison Work with RSLSA

### 1) Social Justice clinic

JBVSS and RSLSA identified the need for social justice clinic program in the entire state of Rajasthan. These clinics were to operate with combined efforts of civil society agencies and Rajasthan State legal Service authority is to make Rajasthan Caste based and labour atrocities free state. After rounds of meetings with RSLSA, the leadership of the esteemed government agency agreed to launch the clinics. RSLSA planned to launch a week-long social justice campaign to create awareness in the stakeholders and capture different Government agencies imagination. In this regard, JBVSS worked on creating awareness documents, posters and time schedule for the clinic and campaign.

The launch of campaign and Social Justice clinic remained unfulfilled task as follow up with the RSLSA was not possible. In total the campaign is delayed by at least 5 months by the end

of September 2022. Also, JBVSS was not able to meet RSLSA and provide the documents for the campaign. Last update in this regard came in the month of September, where deputy secretary of RSLSA wanted contact numbers of people interested to work in Jaipur for helping RSLSA to launch the campaign.

## **2) Rescue operations**

RSLSA supported JBVSS in several rescue operations in 2022. Relationship with RSLSA became vital strategy to firstly, re-introduce bonded labour SOP in the governance ecosystem and secondly in carrying out government lead rescue operations. In the past six months two rescue operations conducted by RSLSA were strategic, these are:

a) **BB brick kiln:** BB brick kiln case was an inter state rescue operation lead completely by government agencies. BB brick kiln case is a human trafficking case where husband who was looking for his family was kidnapped and beaten up by the accused. Rajasthan and Haryana state legal service authority jointly cooperated to find the missing person and rehabilitate family back to their native place.

b) **Joganiya Brick kiln:** Joganiya brick kiln saw Government agencies leading a textbook rescue operation where SOP was strictly adhered. The rescue operation saw release and rehabilitation of 15 bonded labour and received 9 victims received release certificate. The rescue operation was headed by RSLSA and carried out DLSA Bhilwara.

3) **Bonded Labour Action Month:** According to official RSLSA Calendar, for the first time in in the past several years a state government agency planned and carried out action month on bonded labour in Rajasthan. The activities charted out by RSLSA for action month were covering all aspects of bonded labour plight such as awareness, identification, rescue, rehabilitation, linking to government schemes, inspecting vulnerable sites and repatriation. The BL action month was carried out by each district of Rajasthan through DLSA. The month of May 2022 was decided as Bonded Labour Action month.

## **II. Vigilance Committees**

Bonded labour Vigilance committee is a district level mechanism in place to support identification and awareness on bonded labour. System reform division filed RTI in every district of Rajasthan to map the working of these committees. Questions asked on the RTIs

were list of members of the committee, pending fund with the committee, meetings schedule and minutes of meeting of these committees. Till 30<sup>th</sup> September only 5 districts replied to these RTI, stating that the committee was created recently and no meetings were held or are scheduled. However, the fund in the committee remains pending in these districts.

Rajasthan's status on vigilance committee working remains bleak and JBVSS received no positive communication from government agencies to revive these committees.

### **III. Police Academy Training**

JBVSS along with partner agency conducted a police training on 5<sup>th</sup> May 2022 in Jaipur, Rajasthan. The participants of the training were Constable's rank police officials. The theme of the training was Bonded labour procedures and the role of police in its prevention. Training was essential part of system reform activities for the success of the program. A call for second training was also done by training academy officials, however further trainings did not happen.

## **Rehabilitation**

### **I. Skill course and Local artisanship courses**

JBVSS identified need for starting skill and local artisanship course for Rajasthan residing survivors of bonded labour to strengthen their financial health. A big factor in labour exploitation is migration. To stop the re-victimization of the survivors JBVSS felt need for creating self-livelihood opportunities. JBVSS initiated collaboration with other civil society and government agencies for trainings of survivors. JBVSS rehabilitation department approached Development commissioner of Udaipur handloom industry, industry and commerce centers, ICICI SETHI, and NABARD for trainings and skilling up the survivors. JBVSS identified Credit schemes for starting survivor's new businesses. Although, the plans were not executed due to paucity of funds.

### **II. Strengthening Chhattisgarh residing victims**

JBVSS linked Rural engineering case survivors residing in Chhattisgarh to government scheme according to CSS and Rajasthan state labour department notification. The work



included providing documents to labour department in Rajasthan, give representation to labour department for release of RC money.
